MESSAGE FROM THE EXECUTIVE DIRECTOR



It is with pleasure and a sense of pride that I present to you the 2014-2015 Annual Report. The members of the Canadian Institute for Research on Linguistic Minorities (CIRLM) team conducted research work that helps shed some light on the issues faced by the official language minority communities (OLMCs). Researchers and stakeholders in the field of official languages know that there are many issues. The Institute team was involved in research and knowledge dissemination projects that reflect the interests of researchers regarding language issues. Without listing them all, some of the projects carried out included research on bilingualism, immigration and cultural diversity in a minority setting; on the availability (offer) and use (demand) of services in French; on the use of French in the workplace; on language training; on the income disparities between

Anglophones and Francophones; on the historical awareness of Anglophone stakeholders; on the leadership of youth within decision-making bodies; on community governance and innovation; on food safety, etc.

The research efforts have generated several knowledge dissemination activities, both in the academic and community circles. The Institute team published numerous reports, articles or book chapters, in addition to presenting research outcomes during academic seminars or conferences, and even webinars in the community sector. The past year saw the release of two publications in the new collection *Langues officielles et sociétés* that is managed by myself and Anne Robineau with the Presses de l'Université Laval. Under the leadership of Rodrigue Landry, a first work was published to present the results of analyses carried out by several researchers on data collected from Statistics Canada's post-censal survey on the vitality of official-language minorities. More recently, Linda Cardinal and I published *Gouvernance communautaire et innovations au sein de la francophonie néobrunswickoise et ontarienne* in the same collection in order to present the results of the researchers who contributed to the Research Alliance's *Les savoirs de la gouvernance communautaires* directed by Linda Cardinal. Four other publication projects are currently being prepared as part of this collection, which is clear evidence that our collection meets a need.

As for our *Linguistic Minorities and Society* journal, we published an issue entitled *Le français en milieu minoritaire: défis et enjeux* this year. Another issue was recently published on the issues of legitimacy within the Francophone linguistic minorities. Several other issues are currently being drafted, including an issue dealing with health and another one more specifically on mental health in Francophone minority communities, as well as an issue on diversity in Quebec.

The Institute is now trying to contribute to—even foster—debates on the issues surrounding the development and vitality of the OLMCs. Written in collaboration with Michel Doucet of the International Observatory on Language Rights, a report dealing with the funding for the Francophonie allowed to raise some questions about this crucial issue for the French-speaking players. The researchers at the Institute are in a better position to raise certain issues that could cause concerns within the organizations; but given their relations with the donors, it is difficult to formulate them publicly. The relevancy of the issues raised in our report was confirmed by the invitation that was presented to us at the Leaders' Forum led by the FCFA since the *Sommet sur les communautés francophones et acadienne* took place in 2007.

Funding is also an issue for the research efforts relating to the OLMCs and remains a source of concern. We know that research is an essential component for supporting the efforts of community and government players seeking to foster the development and vitality of the OLMCs. Granting agencies such as the SSHRC and CIHR abolished these past few years the subsidy programs that targeted research projects relating to the OLMCs, instead adopting internal measures for assessing the applications submitted. It would be interesting to assess the outcomes of such measures from the perspective of research on the OLMCs. Moreover, the federal government funds research in some fields, i.e. health and immigration, but the terms vary depending on the Department. On the francophone side, in health, the funding is channeled through the CNFS, that ensures funding is provided to researchers affiliated with its member institutions. This way, the CNFS contributes to the development of the francophone institutions' research capabilities. In immigration, the funding is managed by the Department of Citizenship and Immigration that operates via calls for proposals. Launching a call for tenders does not guarantee the funding will benefit the communities' researchers at teaching and research institutions. As for Heritage Canada, this Department no longer funds research on the OLMCs. Thus, depending on the Department, when such support is

available, the support for research takes on different forms. We believe that it would be preferable for Departments to follow a similar research policy and acknowledge its importance for the development of OLMCs.

Today's context of research funding urges us to diversify our sources of funding, which allows us to take up work in response to the numerous concerns of players in the field. Their questions often open up new avenues for research on OLMCs. Regular and associate researchers at the Institute are often called upon to conduct work in new research fields.

This report will give readers a more detailed account of the research and dissemination activities carried out by the members of the Institute team. These outcomes are the result of team efforts that rely specifically on the commitment of several associate researchers. I would like to take this opportunity to acknowledge the dedication of the Institute team members as well as the cooperation of the associate researchers and all those who had a hand in our accomplishments.

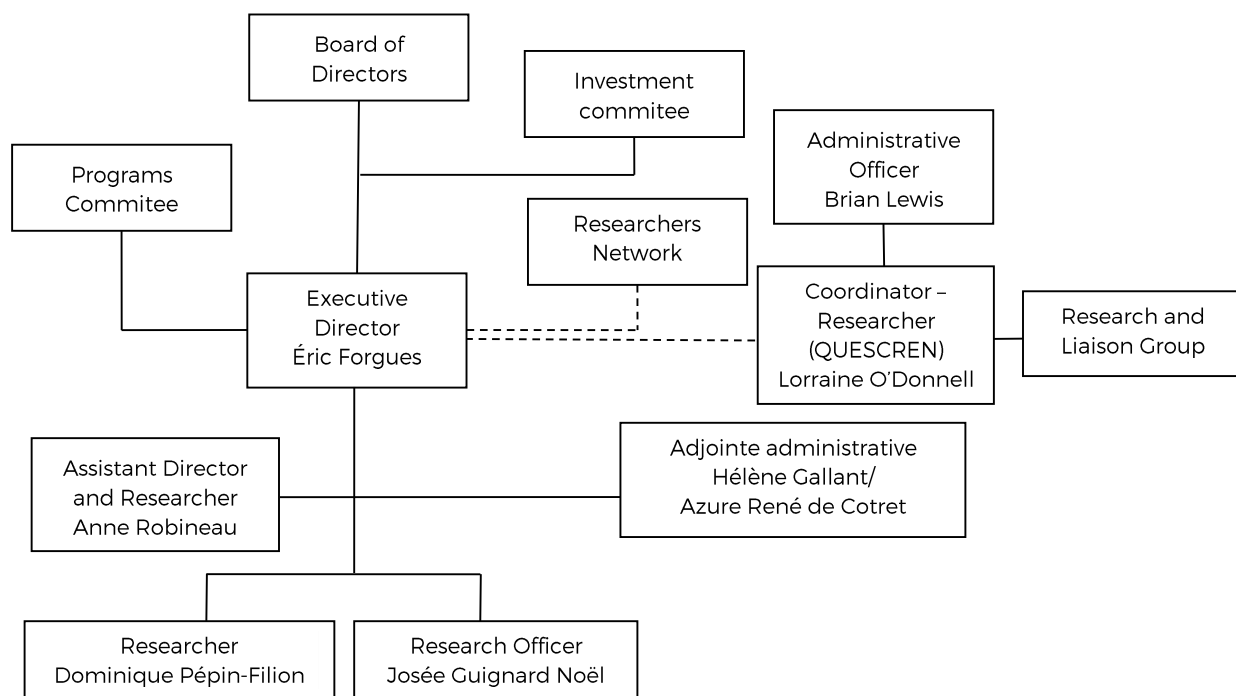

Internet

CIRLM has launched its new website in December 2014 (www.icrml.ca) and has been reconfigured to improve the user's browsing experience and make accessing information easier. CIRLM would like its website to be a user-friendly tool for those interested in research on official language linguistic minorities in Canada. Du 1^{er} avril 2014 au 31 mars 2015, l'ICRML a accueilli environ 11 298 visites dont 69 % sont de nouvelles visites.

Also the CIRLM website has a directory of researchers on Official Language Minority Communities (OLMC) including a registration form (there are currently 120 researchers listed). This section is being improved so that users can search not only by the first and last name of the researchers but also by their research interests. Recently, the CIRLM also added a directory of research teams, groups, centres and institutes on OLMC.

To promote its events, the CIRLM sends regular newsletters to members on its mailing list (currently 524 subscribers as of March 31, 2015). As another means of communication, the CIRLM created a Twitter account (twitter.com/ICRML_CIRLM). This social networking tool enables the CIRLM to send instant news updates. Created in June 2012, the CIRLM's Twitter account now has 227 followers.

As well, the CIRLM has a bibliographic database, accessible online through the CIRLM website, with 5,400 references. For 2015, CIRLM is planning the restructuring of the database for a better user accessibility.

As for QUESCREN, it has its own website (www.quescren.ca) and continued to add titles to its online annotated bibliography of publications on Quebec's English-speaking communities. Compiled by volunteer Brendan O'Donnell. Total number of titles listed: 9825 as of March 2015.

QUESCREN produced English- and French-language newsletters in April, May, July and October 2013 and January 2014 and also sent out five additional brief updates with invitations for events.
