MESSAGE FROM THE CHAIR



As Chair of the Board of Directors of the Canadian Institute for Research on Linguistic Minorities (CIRLM), I am pleased to present our 2015-2016 Annual Report. The Institute's mission is still just as relevant as ever to the development of official language minority communities (OLMC). The production of solid data such as that from the CIRLM is essential to the governance of OLMCs, which is based on growing collaboration between the communities and their government partners. The CIRLM's activities also help to spread awareness of OLMCs and their challenges. As you read the report, you will see the diversity of the projects carried out by the CIRLM and its associate researchers. These projects deal with various strategic and thematic fields of research, such as services in French in the fields of healthcare and justice, migration, models of community governance, identity and linguistic practices, culture and community heritage. They also target various groups, including seniors, youth and women, as well as various problems of urban and rural communities.

The CIRLM's team is active in organizing conferences and participating in forums, commissions and advisory committees. Members improve and share their expertise with scientific collaborators, community stakeholders and political decision-makers across Canada. Thanks to the quality of the research done by the Institute, the Institute's members are regularly called on for expert opinions in cases dealing with language, to speak to the media or to serve on panels assessing funding for research on OLMCs (such as the Consortium national de formation en santé). One of the Institute's main strengths is its capacity to create an environment that fosters interdisciplinary research and makes the most of the knowledge of its various community and government partners. Indeed, this is why the CIRLM has been able to produce a number of important studies despite decreased funding for research in Canada in recent years. In Québec, the Québec English-Speaking Communities Research Network (QUESCREN) has also undertaken and maintained a number of research and networking activities that have helped to spread awareness of the reality of these communities among researchers and the general public in areas such as education, health and heritage.

Thus the CIRLM is continuing to work successfully on developing capacity for research on OLMCs by diversifying its partnerships and increasing dissemination of the research through improvements to its bibliographical database, its online journal and its collection of books from Les Presses de l'Université Laval. The Institute is well prepared to meet the challenges of tomorrow with respect to valuing research in an era of social media. We want to congratulate the Executive Director, Mr. Éric Forgues, and his team for their initiatives and the quality of their work to produce and promote knowledge on OLMCs. Happy reading

MOT DU DIRECTEUR



The year 2015-2016 showed just how socially relevant is the research carried out by the Canadian Institute for Research on Linguistic Minorities. New Brunswick's Commissioner of Official Languages invited the CIRLM to analyze the evolution of bilingualism in the province, and Ontario's French Language Services Commissioner asked for its opinion on the notion of active offer and the importance of mentioning it clearly in the Ontario's French Language Services Act. Health Canada called on its services to inventory healthcare facilities providing services in the minority language across the country. The Société de l'Acadie du Nouveau-Brunswick asked it to participate in a collective examination of Acadian governance in New Brunswick and the Société Nationale de l'Acadie invited it to lead a consultation on the future of the Congrès mondial acadien. The CIRLM also produced a report about the migration of young Francophones in Canada for the Fédération des communautés francophones et acadienne and the Quebec organization Place aux jeunes en région. In the field of justice services in French, the Association des juristes d'expression française du Nouveau-Brunswick called on the CIRLM to do a situational analysis. We are also regularly asked by law firms to share our expertise on linguistic minorities. Moreover, we participate in consultations by governments and community organizations on various issues in research, and more broadly, on the situation of official language minority communities (OLMC).

These examples show that the CIRLM team seeks to maintain collaborative connections between researchers and community and government stakeholders to facilitate knowledge sharing.

The CIRLM continues to manage the journal *Linguistic Minorities and Society* thanks to the good work of its Director, Réal Allard, whose excellent and thorough work I wish to bring to your attention. This year we published an issue entitled *Research Benefiting Better Access to Health Care Services in French*. Other issues are in preparation, including one on Diversity, Ethnolinguistic Boundaries and Education in Québec and Canada and another on *Mental Health of OLMC Youth in Canada: Situational Analysis*.

The CIRLM continued to direct the collection *Langues officielles et sociétés* from Les Presses de l'Université Laval. In the past year, one work was published in the collection, *L'Acadie politique* by Michelle Landry. Two other book projects are in the course of being printed and two are in preparation, and we recently received another book proposal. I wish to thank Denis Dion from Les Presses de l'Université Laval for his excellent service since the collection was created.

The CIRLM supports Statistics Canada's Research Data Centre (RDC) located at Université de Moncton. The RDC provides access to several of Statistics Canada's databases, allowing for quantitative analyses on a number of themes affecting OLMCs.

The CIRLM continued to support QUESCREN, which continued its consolidation efforts this year by renewing and expanding its advisory board. This includes representatives from English and French universities in Québec and from the governments of Québec and Canada. We applied for funding from Canadian Heritage to support the development of the Network.

Readers of this Annual Report will find more details on research and dissemination activities by members of the CIRLM. These results are the fruit of teamwork in which each member plays a role in the CIRLM's success. They also lean on the commitment of a number of associate researchers and partners who have contributed to the CIRLM's achievements.





Internet

CIRLM has launched its new website in December 2014 (www.icrml.ca) and has been reconfigured to improve the user's browsing experience and make accessing information easier. CIRLM would like its website to be a user-friendly tool for those interested in research on official language linguistic minorities in Canada. From April 1, 2015 to March 31, 2016, the CIRLM website had approximately 8,021 visits, of which 69.1% were new visits.

Also the CIRLM website has a directory of researchers on Official Language Minority Communities (OLMC) including a registration form (there are currently 123 researchers listed). This section is being improved so that users can search not only by the first and last name of the researchers but also by their research interests. Recently, the CIRLM also added a directory of research teams, groups, centres and institutes on OLMC.

To promote its events, the CIRLM sends regular newsletters to members on its mailing list (currently 535 subscribers as of February 29, 2016). As another means of communication, the CIRLM created a Twitter account (www.twitter.com/ICRML_CIRLM). This social networking tool enables the CIRLM to send instant news updates. Created in June 2012, the CIRLM's Twitter account now has 309 followers.

As well, the CIRLM has a bibliographic database, accessible online through the CIRLM website, with 5,500 references. For 2016, CIRLM is planning to complete the restructuring of the database for a better user accessibility.

As for QUESCREN, it has its own website (www.quescren.ca) and continued to add titles to its online annotated bibliography of publications on Quebec's English-speaking communities. Compiled by volunteer Brendan O'Donnell. Total number of titles listed: 10 418 as of February 2016.

QUESCREN produced English- and French-language newsletters in April, July and October 2015 and January 2016 and also sent out five additional brief updates with invitations for events. The newsletter provides subject-level access to news on publications, projects and events related to ESCQ research. Diffusion to 640 recipients as of February 2016.

Consultation: two meetings of the Research and Liaison Group (a steering committee) of the Quebec English-Speaking Communities Research Network (April and October 2015) and one meeting of the new QUESCREN Advisory Board, which replaces the Research and Liaison Group (February 2016).

Lorraine O'Donnell, coordinator-researcher of QUESCREN, is responsible for research, coordination, administration and management of this research unit. She also participates in CIRLM activities (staff meetings, Program Committee meetings) and in activities at Concordia University, where QUESCREN is situated.

Since September 2015, Lorraine O'Donnell is Affiliate Assistant Professor in Concordia University's School of Community and Public Affairs.
